80% and above in Boards in both subjects

HUMANITIES

65% and above in Internal Exams
for Maths & Economics
80% in maths in Boards for those opting

Students should secure pass marks in the second language.

The responsibility for the correct selection of subject to meet the University or professional requirement of a candidate or candidates will be that of the candidate and the parents/guardians.

Registration Process

1. Cost of Admission Form is **₹1500 (non-refundable)**
2. The Registration forms are to be filled in **CAPITAL LETTERS**.
3. Registration does not imply Admission, which is subject to the Meeting with the School Authorities and availability of seats.
4. Incomplete Registration form and/or incorrect information will be treated as invalid. The percentage of marks obtained in all subjects and the aggregate should be clearly mentioned in the Registration form. In case of any discrepancy with the facts, the School Authority reserves the right to cancel the Registration form as well as the Admission of the candidate.
5. Dates for the Meeting will be intimated during Registration. However, these may be changed, with prior notice.
6. **Both or either of the parents must reside with the child during his/her tenure in DPS Newtown**
7. At the time of registration, a processing fee of **₹1200 (non-refundable)**, in addition to Admission Form cost of **₹1500**, is to be deposited along with the following documents:
 - a) Duly filled up and signed Registration form.
 - b) Class X Admit Card /Birth Certificate issued by Municipality or Corporation in support of Date of Birth duly attested by the School Principal/Gazetted officer.
 - c) Proof of residence of the parents (e.g. passport/electricity bill/telephone bill/rent bill or lease agreement of house/flat.)
 - d) Class IX final/class X half yearly/Pre-Board mark sheet duly attested by the School Principal or a Gazetted Officer.
 - e) Two identical colour photographs of the student on the Registration form as well as Admit card. Colour photographs of the parents to be uploaded.
 - f) ID Card of existing students of DPS Newtown to be submitted at the time of Registration.
 - g) Aadhar Card.

Interaction

1. Interaction will be held between the PRINCIPAL/VP, STUDENT AND PARENTS
2. Securing mere cut-off marks is no guarantee for Admission.
3. Provisional Admission will be granted to shortlisted students only of the student's performance in the meeting with School Authorities is satisfactory

Admission Procedure

1. Provisional Admission to Class XI will be confirmed only if the candidate passes in the Class X Board Examination and fulfils the Eligibility criteria.
2. The Admission formalities will be intimated to the parents/guardian of the selected candidates. The Admission fee is to be paid within the due date informed by school authorities.

3. It is mandatory to submit the Transfer Certificate from the last school attended (for external candidates).
4. Fees paid at the time of Admission except the security deposit (provided all dues are cleared) will not be refunded in case of withdrawal of the candidate by the parent or if Admission is rejected on the grounds of not fulfilling the ICSE Eligibility criteria.
5. In case of change of board, candidates seeking Admission in class XI will be required to submit a Migration Certificate & true copy of the Mark Sheet.
6. The Management reserves the right to take the final decision in all matters relating to Admission.

Transport Incidental Charges **₹300** per month If opting for private car pool service, 10th day of every quarter

To opt for School Bus service a separate Transport Registration Form has to be filled up and submitted at the School Office.

Note: -

- ❖ The above Fees are subject to revision from time to time at the sole discretion of the School Authorities
- ❖ For fees paid after due date, a late fine will be applicable, details of which will be available in the school almanac and website
- ❖ In case of withdrawal of a student, TC Application Form should be submitted one month in advance to the School Authority
- ❖ If for some reason, the notice period is less than one month, tuition fee, bus fee (if applicable) in lieu thereof is to be deposited
- ❖ The Security Deposit is refundable after adjustment, if any, at the time a student finally leaves the School
- ❖ In case a student takes admission in the middle of a quarter/session, the education fees/lab fees for the particular quarter needs to be paid in full
- ❖ **Once a student starts attending classes, the Annual Maintenance Charge for the whole year has to be paid even in case of a mid-session withdrawal. Once a new session starts application for cancellation of a new admission will be considered as mid-session withdrawal.**

- ❖ **Admission fees once paid will not be refunded.** Only the security deposit will be returned in case of cancellation of admission
- ❖ **School Bus service will be made available subject to vacancy in the bus route of choice**
